November 15th Meeting – Finksburg History:

The November meeting will be a community conversation about the history of Finksburg. We will begin with a short presentation on The Elms, a stately mansion situated on the old carriage road along the west bank of the Patapsco River just south of the present day Rt. 140 bridge over Liberty Reservoir. The house was built in approximately 1760 and at one time belonged to the son of Francis Scott Key. It was destroyed when the Liberty Reservoir was constructed, but some still remember this fine old Maryland home. Share your knowledge of Finksburg's history:

Development Updates:

Deer Park / Nicodemus Road Bridge

Baltimore city is scheduled to replace the existing bridge. A community meeting was held on this project on October 24, 2007 at the Franklin Elementary School library. While we have no official attendance count, it was standing room only. The current bridge, built in 1953, will be replaced starting in the summer of 2009. It is anticipated that the bridge will be closed and detours in place for at least 1.5 years.
