# FINKSBURG HOTEL – PROPOSED DEMO AND RE-DEVELOPMENT OF 3 LOTS:

The Old Finksburg Hotel - The Bureau of Development Review currently is processing a development plan for the Mann property (3051 Old Westminster Pike), located along Old Westminster Pike between Murray Road and Schoolhouse Lane. The proposal for three lots would demolish the current structure that is located on the property. This structure is the old Finksburg Hotel, which was noted as a contributing structure in the Finksburg Survey District (CARR-987), and also had its own field sheet completed for it (CARR-1003).
