## TALKING ABOUT TRASH, WASTE NOT! CARROLL

on West, of Waste Not Carroll, will be our featured guest. Don has lived in Carroll County for 25 years on a small farm outside Westminster with his family. As a result of his business and personal interests, greenbuilding and sustainability issues have become important to him.

Three years ago, he co-founded the Maryland Heartland Sustainable Living Fair, a local non-profit that encourages renewable energy, greenbuilding and sustainable agriculture and lifestyle. Last summer, he started studying solid waste issues in Carroll County, including recycling,

landfills, incineration and other methods of trash disposal. Forming Waste Not! - Carroll was the result. After weighing the options, his local group, in conjunction with a similar group in Frederick County, has committed to opposing the proposed WTE incinerator while exploring more sustainable alternatives.

His talk to the FPACC will concentrate on specific issues of interest regarding the WTE incinerator — cost, oversight, myths and misinformation, and he will discuss some of the alternatives. Obviously, questions from the group will be welcome at the end.

#### **FINKSBURG HOTEL**

Proposed Demo and Re-development of 3 lots.

he Bureau of Development Review currently is processing a development plan for the Mann property (3051 Old Westminster Pike), located along Old Westminster Pike between Murray Road and Schoolhouse Lane. The proposal for three lots would demolish the current structure that is located on the property. This structure is the old Finksburg Hotel, which was noted as a contributing structure in the Finksburg Survey District (CARR-987), and also had its own field sheet completed for it (CARR-1003). Both inventory documents can be found online at http://mht. maryland.gov/Survey\_MIHP\_Search.html by signing in and searching Carroll County. This was discussed at the January meeting and some in attendance were interested in exploring the possibility of preserving these structures.
