n Thursday June 3, 2010 the Carroll County 2010 Master Plan was voted to a 60 day public review by the Carroll County Planning & Zoning Commission. The Carroll County Planning and Zoning Commission will hold a public hearing following the 60-day review period on the recommended master plan. The hearing will be held on Thursday, August 19, 2010, at 7:00 p.m. at the Carroll Community College's Scott Center Auditorium, located at 1601 Old Washington Road in Westminster.
