► Annual Finksburg History Night to Focus on Area Distilleries: 11/21/2019

On Thursday, November 21, the Finksburg Planning and Citizen's Council (FPACC) will hold its annual meeting devoted to local history. This year's topic will be "A Spirited Tale - Alcohol Distilleries in the Woolery's District." The speaker will be Mark Fraser, Ph.D. Dr. Fraser is an avid historian and former curator of the Gatehouse Museum in Sykesville, Maryland.
